ANIMAL CARE

- Assure that all animals entrusted to the care of this department are handled properly, humanely, and with compassion
- Clean and disinfect all animal areas per protocols to maintain a safe and sanitary environment
- Feed and assist Animal Care Technician's II and III with medicating animals under our care
- Identify, vaccinate, weigh, and kennel animals as needed
- Assist Animal Care Technician's II and III with euthanasia as needed in accordance with Marin Humane policies and California laws

CUSTOMER SERVICE

- Acknowledge and assist in training volunteers as needed
- Assist the public in locating lost pets and answering questions
- Understand, support, and articulate organization's policies and philosophies to the public in a positive and effective manner
- Promote and emulate exemplary customer service by providing courteous, prompt and responsive service to internal and external customers.
- Fosters teamwork, creativity and a work culture aligned with Marin Humane's mission and values.

SAFETY AND SECURITY

- Be proficient at reading animal body language and act accordingly towards fearful or aggressive animals
- Model and encourage safe practices and regulatory compliance throughout the organization
- Must be committed to a high standard of safety and be willing and able to comply with all safety laws and all of the employer's safety policies and rules

An ideal Candidate will possess the following knowledge, skills and abilities:

- Ability to stay focused, professional and calm in a fast paced, emotionally charged environment
- Consistently demonstrates accuracy, thoroughness, neatness and dependability to produce work within acceptable standards
- Ability to administer vaccinations and other medications to domestic animals as needed
- Accumulated knowledge of and compassion for animals
- Good customer service skills
- Ability to manage multiple tasks in a fast paced environment and to adjust to tasks in accordance with changing deadlines and priorities
- Capable of working both independently and as a member of a team
- Basic knowledge of Microsoft Office and computer keyboarding skills (data entry)
- Good oral and written communication skills
- Must be available to work irregular hours, weekends and holidays

Possession of valid California drivers' license may be necessary

EDUCATION AND EXPERIENCE: A typical way of gaining the necessary knowledge, skill and ability outlined would be the equivalent of graduation from high school and a minimum of two years experience working with animals, either personally or professionally.

PHYSICAL DEMANDS: The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- While performing the duties of this job, the employee is regularly required to stand and walk throughout the work day;

- This position involves a regular amount of repetitive motion of hands and wrist, use of hands requiring dexterity; reach with hands and arms;
- The employee must regularly lift and /or move up to 50 pounds;
- This position requires frequent talking and hearing in ordinary conversation;
- The employee is regularly required to pull and/or push items weighing up to 20 pounds and occasionally pull and/or push items weighing up to 50 pounds;
- Specific vision abilities required by this job include close vision, distance vision, peripheral vision, depth perception, ability to focus. Color vision is also occasionally required.
